With the approval of the directors present, Robin Masteller acted as Chairman of the meeting and Stephanie Wells recorded the minutes.

1. Approval of Agenda

The agenda was unanimously approved as distributed.

2. Approval of Minutes

3. Announcements

- A) Handicap will continue this year (2011-2012) due to the vote that was done at the banquet in Feb 2011. A recount was done at the meeting and the count was 42 scratches to 51 handicaps. New players to the League will have the 3 dart handicap the first week of darts. All returning league members handicap will

be based off last years ending ppd. Our 501 rep Jason Masteller will be contacting John Schuch and letting him know.

- B)** This year teams will have an 8 man maximum on their roster. Any team that needs a sub this year will have to contact one of the 501 reps, (Mark or Jason Masteller) by the Monday night prior to when your team shoots and ask permission to have a sub. All subs can only have a one point difference between the median of the team they are subbing for. Every sub has to pay the \$8.00 sub fee before they can shoot, paid to a 501 rep or someone otherwise approved by one of the reps . Once the sub shoots they are married to that team's roster and cannot shoot on any other team. Subs that are used in Double A are married to that division there is no median. If any team is caught using a sub without permission all there games for that week will be forfeited. If a sub is seen on two different divisions they will no longer be able to shoot.
- C)** Anyone who plays on a team before December 31st will receive a sanction card. After the 31st the team will be paying a sub fee for the player to shoot and they will not be able to qualify for state.
- D)** If any issues comes up between a team and there home bar the team is not allowed to switch bars without committee approval. Your home bar pays to have you shoot there so it is not fair to them if you decide not to shoot there.
- E)** Dart league starts September 13th.
- F)** Sign-ups are on August 30th following the organizational meeting and September 6th at 7pm both at the Lariat Lanes.
- G)** Organizational Meeting is on August 30th at 7pm at the Lariat Lanes.
- H)** Last night to qualify for state is December 13th.
- I)** PPD qualifying will be after the organizational meeting on August 30th and on September 6th both at 7pm.

4. Open Issues

- A)** At the banquet meeting in Feb, it was voted on that we would hire a Statistician this year. Anyone who is interested in the position needs to submit a resume to a committee member. Application Deadline and salary are undetermined at this time.
- B)** Robin Masteller and Steven (Bubba) McCarty are going over the Rules and Bylaws of our organization and will be presenting a new updated version at our next meeting.
- C)** Bill Leimbeck from D & E wants to start a dart league through the new miniature golf and go carts business. Lance Roberts and Noreen Plumage are going to contact them and try and work with them to make sure that they don't have it on the same night we do.
